**ORDER DIRECTING EMPLOYER TO MAKE DEDUCTIONS  
FROM DEBTOR-EMPLOYEE'S INCOME AND PAY TO TRUSTEE**

A Chapter 13 case has been filed by the above-named Debtor and as a result thereof, all future earnings of the Debtor are under the exclusive jurisdiction of this Court, pursuant to 28 U.S.C. Sec. 1334(e), and 11 U.S.C. Sec. 1306(a)(2). It further appears to the Court that the Debtor's employer is:

IT IS FURTHER **ORDERED**, PURSUANT TO 11 U.S.C. Sec. 1325(c), that the Debtor's Employer immediately deduct from the Debtor's next paycheck the sum of \$      and a like amount thereafter each pay period thereafter, including any period for which the Debtor received periodic, or lump sum payment for vacation, termination, or other benefits arising out of the past or present employment of the Debtor, and forward the amounts deducted to the Chapter 13 trustee until further order of this Court. The Chapter 13 trustee's mailing address is as follows:

IT IS FURTHER **ORDERED**, pursuant to 11 U.S.C. Sec. 362(a), that the EMPLOYER SHALL CEASE ALL FUTURE DEDUCTIONS FOR GARNISHMENT, WAGE ASSIGNMENT, OR CREDIT UNIONS unless specifically authorized by this Court, or until this Order is modified or vacated; provided, however, deductions for any amounts required to be withheld by any laws of the United States, the laws of any state or political subdivision, pursuant to any insurance, pension, or union dues agreement between the Debtor and the Employer, and for any future child support may continue in accordance with the Employer's usual payroll procedure.

It is further **ORDERED** that if the Debtor's employment is terminated during the term of the plan, the Chapter 13 trustee should be so advised by the EMPLOYER.
